

JEFFERSON COMMUNITY COLLEGE BOARD OF TRUSTEES

MEETING MINUTES February 8, 2024

The regular monthly meeting of the Board of Trustees of Jefferson Community College was held on Thursday, February 8, 2024, in Room 6-220, Board Room, of the Jules Center at Jefferson Community College.

<u>Call to Order</u> Vice Chair Cindy Intschert called the meeting to order at 4:01 p.m.

Approval of Minutes

On a motion made by Judy Gentner, seconded by Damon Draught, the minutes of the January 3, 2024 meeting were approved unanimously.

Introductions of Guests

Privilege of the Floor - None.

JCC Foundation – Nathan Hunter

Trustee Hunter noted the January meeting of the Foundation Board was cancelled due to weather and summarized the written report of the Foundation as follows:

- The February 2024 Annual Fund appeal will be sent on February 10.
- The Annual Jeff-Can Solicitation will be mailed at the end of February.
- Adam LaClair from Haylor, Freyer and Coon joined the board in January.
- The Foundation Board approved a \$20,000 gift to the College to support Dr. Dupee's inauguration celebration to be held May 30.
- The GWCC Business After Hours that was scheduled for April 17 at the NEST has been postponed.

There were no questions.

Student Trustee Report - Tye LaClair

Trustee LaClair, excused from the meeting due to illness, provided a written report. There were no questions.

President's Report

In his report, Dr. Dupee updated Trustees on enrollment, campus initiatives, events and recent activities. Notables include:

- Spring enrollment is down about 4.9% as compared to last year at this time.
- NYS just expanded Tuition Assistance Program (TAP) funding to include eligible microcredentials; ten of Jefferson's eleven microcredentials meet the criteria.
- Organizational Structure: the process for selecting department chairs has been sent out to campus; interviews for the AVP-Liberal Arts and AVP-Enrollment Services positions will be conducted soon; the AVP-Student Affairs and AVP for Assessment, Planning and Institutional Effectiveness jobs have just been posted. Once these positions are filled, work will begin on the non-Provost side of the organizational structure.
- The North Country REDC received a \$10M award from NYS for a program designed to keep transitioning Soldiers here in the North Country by providing training and access to good paying jobs. The College is part of this program. More details to follow soon.
- Budget Advocacy at the state level conversations continue about community college funding; the SUNY Chancellor provided testimony today at the NYS Joint Legislative Budget Hearing on Higher Education. At the federal level, the President and Karen Freeman attended the National Legislative Summit in Washington, DC earlier this week. Karen attended meetings with Senators Schumer and Gillibrand, while President Dupee and other community college presidents met with the Office of Science & Technology Policy, Department of Commerce, Department of Labor, National Science Foundation and CHIPS Act leaders.
- Recent meetings of note include with the SUNY Workforce 2030 Committee (President Dupee is one of just four community college presidents serving on this committee), and a meeting with Micron about what programs they are seeking from educational partners. It was asked what other community colleges are working with Micron. Dr. Dupee advised Onondaga Community College is one.
- Hosted a Community Breakfast on January 19 with many community leaders in attendance; President Dupee provided an update on College initiatives and budget advocacy.
- Met with Jefferson-Lewis BOCES to further discuss the "Grow Your Own Teacher" initiative aimed at helping high school students become teaching assistants and then follow a path, via Jefferson and Potsdam, toward a master's in teaching.

- Met with SUNY Canton about potential academic partnerships and met with Lewis County to begin mapping out a strategic plan for use of the Education Center in Lowville in conjunction with BOCES.
- Recent activities include Spring Semester Convocation on January 19, delayed due to inclement weather, Cannoneer Kick off also on January 19, and JCC Night at the Watertown Wolves on January 26 with about 60 employees and family members in attendance.
- Finally, President Dupee attended the commencement ceremony at Cape Vincent Correctional Facility
 and celebrated a Jefferson graduate. This is only the second student to complete a Jefferson degree
 while incarcerated.

Finance and Audit Committee - Committee Chair Damon Draught

Trustee Draught noted the Finance and Audit Committee met prior to the full Board meeting. During that meeting, Tim Hammond and Greg Evans from the Bonadio Group reviewed the College's FY23 audit, which received a clean, unmodified opinion. Trustee Intschert offered kudos to VP Sid Pond, Sintia Marshall and the financial operations team for their good work.

Upon motion by Damon Draught, seconded by Nate Hunter, the College's FY23 Audit in Resolution 110-24 was approved unanimously as follows:

RESOLUTION NO. 110-24: ACCEPTANCE OF COLLEGE AUDIT

BE IT RESOLVED, that the Jefferson Community College Board of Trustees hereby accepts the attached audit of the financial statements of Jefferson Community College for the year ending August 31, 2023 as prepared by The Bonadio Group.

Next, Trustee Draught presented three 2023-2024 budget amendments. Resolutions 111-24, 112-24 and 113-24 all recognize new or additional funding in the 2023-2024 budget. Resolution 111-24 acknowledges Liberty Partnership Program funding. Resolutions 112-24 and 113-24 acknowledge transformation funding from SUNY. The funding in Resolution 112-24 will be used to support the ASAP (Accelerated Studies for Associate Programs) initiative, and a portion of the funding in Res. 113-24 is dedicated to initiatives that support the nursing program.

Upon motion by Damon Draught, seconded by Michael Crowley, the budget amendments contained in resolutions 111-24, 112-24 and 113-24 were approved unanimously as follows:

RESOLUTION NO. 111-24: 2023-2024 BUDGET AMENDMENT LIBERTY PARTNERSHIP PROGRAM GRANT

GRANT PERIOD: SEPTEMBER 1, 2023 – AUGUST 31, 2024

WHEREAS, funds have been received from the New York State Education Department (SED) to implement a 12-month Liberty Partnership Program in conjunction with the Watertown City School District, the Watertown Family YMCA and Cornell Cooperative Extension;

WHEREAS, the Watertown Liberty Partnership Program (WLPP) will provide structured and individualized support services through a hybrid school-based, after-school, and summer program

model. A total of 200 at-risk students in grades 5-12 will be served in each year of this multi-year grant;

THEREFORE, BE IT RESOLVED, that the Jefferson Community College Board of Trustees hereby approves the following budget amendment:

Financial Statements: December 2023

Vice President Sid Pond provided a brief overview of unaudited December 2023 financial reports. He reported that four months into the fiscal year Fall tuition revenue is lower than budget by about \$181,300 or 4.4%. Overall revenue is down about \$248,200 or 1.6% as compared to last year. Expenditures are lower than budget by about \$820,000 or 3.2% and down about \$28,000 compared to last year at this time. The College is monitoring Spring enrollment and will continue to monitor expenses to help offset the reduced Fall tuition revenue. There were no questions.

Upon motion by Damon Draught, seconded by Nathan Hunter, the Board unanimously accepted December 2023 financial reports.

Academic and Educational Services Committee - Committee Chair Cindy Intschert

Trustee Intschert noted the Academic & Educational Services Committee did not meet in January, however the Academic Calendar for the Spring 2025 semester was discussed at the December 20 committee meeting. The College was hoping to align its Spring break with the K-12 spring break, however it is not possible to due to how late in April the K-12 spring break will be held.

Upon motion by Judy Gentner, seconded by Steve Todd, the Spring 2025 calendar contained in Resolution 114-24 was approved unanimously as follows:

RESOLUTION NO. 114-24: ACADEMIC CALENDAR SPRING 2025

WHEREAS, Jefferson Community College Board of Trustees Resolution No. 118-85 directs the formation each year of the Academic Calendar Workgroup for the purpose of reviewing and recommending the academic calendar; and

WHEREAS, the Academic Calendar Workgroup has proposed an academic calendar for the Spring 2025 semester as described in a memorandum dated December 12, 2023;

NOW, THEREFORE, BE IT RESOLVED, that the Jefferson Community College Board of Trustees hereby adopts the attached academic calendar for Spring 2025 as developed and recommended by the Academic Calendar Workgroup.

Facilities Committee – Committee Chair Stephen Todd

Trustee Todd reported the Facilities Committee met on January 29. There are no action items, however the committee discussed the following:

- The paving of lots C and D will be completed using \$1M from Jefferson County and \$1M match from the State. That work will begin right after commencement and take about 10-12 weeks.
- The tennis courts will be refurbished, adding pickleball courts and possibly a basketball court and lighting for a portion of the space. The exact configuration is still being worked out. The project cost is estimated to be \$700K.

• VP Pond and President Dupee initiated conversation with County about the College's next bonding request for funding which will be earmarked for campus revitalization projects.

There were no questions.

Personnel Committee – Committee Chair Beth Fipps

Trustee Fipps reported that the Personnel Committee did not meet in January, however the 2024-2025 Holiday Schedule in Resolution 115-24 was reviewed and discussed at the Committee's December 20 meeting.
