<u>Call to Order</u> Vice Chair David Males called the meeting to order at 4:00 p.m.

Approval of Minutes

Vice Chair Males noted that Dr. Dupee's appointment as Jefferson's president was approved yesterday at the June 6 meeting of the State University of New York Board of Trustees. He offered his congratulations to Dr. Dupee and read aloud Resolution 130-23, unanimously approved by Jefferson's Board of Trustees on March 23, 2023, which selected Dr. Daniel Dupee, II as Jefferson's 7th president. Vice Chair Males noted the resolution had been amended in April to include base salary and estimated start date. The reading of the resolution was followed by a round of applause from Trustees and guests.

RESOLUTION NO. 130-23

SUBJECT: APPOINTMENT OF 7th PRESIDENT OF JEFFERSON

COMMUNITY COLLEGE

April 5, 2023: Amended to include base salary and start date

WHEREAS, in September 2022, the Jefferson Community College Board of Trustees commenced a search for the College's 7th president; and

WHEREAS, in March 2023, the Presidential Advisory Search Committee concluded its work by recommending four finalists to the Board of Trustees; and

WHEREAS, each finalist visited campus, met with campus constituencies and was interviewed by the Board of Trustees; and

WHEREAS, on March 23, 2023, Trustee Judith Gentner made a motion to appoint Daniel J. Dupee, II, as seventh president of Jefferson Community College. The motioned was seconded by Trustee Michael Crowley and approved unanimously.

THEREFORE, BE IT RESOLVED, that the Board of Trustees of Jefferson Community College hereby appoints Daniel J. Dupee, II, to serve as the President of Jefferson Community College effective June 1, 2023 at an annual rate of pay of \$205,000, subject to the approval of the Board of Trustees of the State University of New York.

JCC Foundation Update

Dr. Dupee gave the report of the JCC Foundation. He summarized the written report as follows:

• The last Annual Fund solicitation for the year, signed by Dr. Dupee, mailed on June 1.

- At the May 10 Foundation meeting, the Board approved \$30,000 to the Athletic Department for three video scorer tables for the gymnasium and heard a presentation on "Handshake," a college-to-career networking software program.
- Thus far, 215 Foundation scholarships worth \$153,316 have been awarded to students for Fall 2023. Over 65 scholarships, valued at about \$100,000, remain and will be awarded this fiscal year. Dr. Dupee noted there are 39 Jefferson-Can Community Scholars enrolled for fall, a 22% increase from last year.

Student Trustee Report

Student Trustee Gianna Donahue reported that Student Government held Executive Board elections for the coming year and shared the following results:

Trustee Donahue also reported the Campus Activities Board and Student Activities & Inclusion hosted Senior Send-off on Commencement Day. Attendees were given a diploma certificate frame.

There were no questions.

President's Report

For his report, Dr. Dupee updated Trustees on enrollment, campus initiatives, events and recent activities. Highlights include:

- Summer enrollment is down about 7% and fall enrollment is up just slightly over last year at this time.
- The Bookstore is in the process of transition to a Barnes and Noble bookstore. Early summer session students received books from Follett, while starting June 5, students will get books from Barnes and Noble. Barnes and Noble will launch the "First Day Complete" credit based book program for students enrolled in fall semester classes.

- Jefferson County approved the ESP employment contract and the College's use of \$1M in County stimulus funds for paving projects.
- The findings of the organizational structure survey were send to Dr. Dupee on Monday. Findings
 will be shared with Cabinet and Trustees this summer, and then with the campus for feedback and
 discussion over the course of the fall semester.
- The Turf field project is scheduled for completion in June.
- Academic Program Updates:
 - A Surgical Technologist program will be coming to Jefferson in the fall in partnership with Mohawk Valley Community College. Currently there are 4-5 students registered; the goal is ten students. FDRHPO and NNY Rural Healthcare are going to provide funding in support of this program.
 - Conversations continue to bring Dental Hygiene to Jefferson in partnership with Monroe and two other community colleges for Fall 2024. This cohort will be 5 students.
 - The College is helping Fort Drum Child & Youth Services with recruiting and building a pipeline of educated early childhood and youth services employees.
 - Conversation are occurring with BOCES about moving some of the adult-oriented programs to Jefferson's campus for easy transition to JCC programs.
- The College hosted two successful site visits by NYS for Title IX and the C-STEP program. In fact, the College has already received C-STEP funding for next academic year.
- Recent campus activities include the College's Recognition Celebration, Athletics Banquet, Scholars Day Presentations by Honors Program students, Nurse Pinning and Commencement. In addition, Dr. Dupee attended a meeting with the Workplace, legislative reception in Albany, and the Night on the River for North Country Family Heath Center.
- Coming up, Dr. Dupee will volunteer at AUSA's Riverfest, attend the Fort Drum Graduation Ceremony, speak at the Cape Vincent and Gouverneur correctional facilities graduation ceremonies, attend the SUNY NYCCAP meeting and present the College's proposed operating budget at the Jefferson County Finance and Rules Committee meeting.
- Accolades include Chancellor King's mention of Jefferson's veteran's services program during the State of the University address and the signing of new nursing legislation in Albany which allows nursing students to complete 1/3 of their clinical in simulation labs like Jefferson's nursing lab.

APPOINTMENT OF NOMINATING COMMITTEE

Vice Chair Males asked for three Trustee volunteers to serve on the Nominating Committee, which is charged with bringing forward a recommended slate of officers for the 2023-2024 year. The three Trustees who volunteered, Mike Crowley, Beth Fipps and Cindy Intschert, were then appointed by Vice Chair Males as the Nominating Committee. They will bring forth a recommended slate of officers at the July 12 meeting.

Budget and Planning Committee - Committee Chair Damon Draught

Trustee Draught noted the Budget & Planning Committee met prior to the full Board meeting. He presented two amendments, in resolutions 154-23 and 155-23, to recognize additional funding in the 2022-2023 budget. In addition, he presented resolution 156-23 to write off student debt that has been

deemed uncollectable by the College. These accounts will go to a 3rd party to further attempt collection. Upon motion by Damon Draught, seconded by Mike Crowley, Resolutions 154-23, 155-23 and 156-23 were approved unanimously as follows:

RESOLUTION NO. 154-23 2022-2023 BUDGET AMENDMENT

WHEREAS, funds have been received from the NYS State Education Department (SED) to supplement existing supports and accommodations for SWDs in order to expand such supports and services provided by SUNY;

WHEREAS, the initiative will support college prep programs to assist SWDs in transitioning to college and prepare them to navigate the campus facilities and system, provide full and part-time faculty and staff at SUNY with disability training; and/or to improve the identification process of SWDs and enhance data collection capabilities at SUNY;

THEREFORE, BE IT RESOLVED, that the Jefferson Community College Board of Trustees hereby approves the following budget amendment:

RESOLUTION NO. 156-23: STUDENT RECEIVABLE WRITE-OFF

WHEREAS, in compliance with generally accepted accounting principles, the College should not retain as accounts receivable balances that are deemed to be uncollectable, and;

WHEREAS, the accounts receivable balances set forth in the attached schedule are deemed to be un-collectable;

NOW, THEREFORE BE IT RESOLVED, that the Jefferson Community College Board of Trustees hereby approves the adjustment to the tuition receivable accounts in the amount of \$594,113.48.

Financial Statements: April 2023

Interim VP Bill Emm presented unaudited April 2023 financial reports. He advised that with 95% of all tuition revenue in (summer enrollment is still ongoing), tuition revenue overall is at or above budget. Expenses are in line with budget. Overall, the College is in good financial position and estimates using significantly less fund balance than originally planned. He noted the College's cash investments in Treasury bills have reaped great benefits as interest rates have continued to rise.

There were no concerns or questions. Upon motion made by Damon Draught, seconded by Nathan Hunter, the Board unanimously accepted April 2023 financial reports.

Academic and Educational Services Committee - Committee Chair David Males

Trustee Males reported the Academic & Educational Services Committee met on May 17 and is bringing forward two policies for action. Upon presentation and motion by Trustee Males, seconded by Cindy Intschert, the revision to the Honors Program policy was approved unanimously as follows:

RESOLUTION NO. 157-23: HONORS PROGRAM POLICY

(Revises Resolution No. 111-17, March 2017)

BE IT RESOLVED, that the Jefferson Community College Board of Trustees does hereby approve revisions to the Honors Program Policy as attached.

Trustee Males advised that the second resolution approves a new policy on prior learning assessment (PLA). Jefferson has always had a practice and procedure for evaluating PLA, however under Middle States standards, all colleges must have a PLA policy in place. Trustee Males reported the College had developed this policy last year, but then waited to ensure it aligned with the SUNY policy on PLA which was unveiled in February during the Chancellor's visit to Jefferson. Upon presentation and motion by Trustee Males, seconded by Damon Draught, the new Prior Learning Assessment Credit Policy was approved unanimously as follows:

RESOLUTION NO. 158-23: PRIOR LEARNING ASSESSMENT CREDIT POLICY

BE IT RESOLVED, that the Jefferson Community College Board of Trustees does hereby approve the attached Prior Learning Assessment Credit Policy.

<u>Middle States Update</u>: Trustee Males also reported that Self-Study editor, Mike Avery, has solid drafts of Chapters 1 -3 which are being reviewed by the Steering Committee. The Steering Committee expects to have a draft of the full Self-Study to share with campus at the beginning of the fall semester. Once feedback is received and edits made, the draft Self-Study will be shared with the Visiting Team Chair prior to his visit to campus in late October/early November.

<u>Facilities Committee</u> – Committee Chair Pamela Beyor-Murtha

Chair Murtha noted the committee did not meet last month and therefore there was no report, however she invited Trustees to tour the turf field project following the meeting.
