## JCC Foundation - Nathan Hunter

Trustee Hunter summarized the written report from the Foundation, highlighting the upcoming Inauguration Celebration and kick-off of the Community Impact Fund for Career Education, along with other updates.

# Student Trustee Report - Tye LaClair

Trustee LaClair was unable to attend, but submitted her written report which was reviewed by Chair Males. The report highlighted recent and upcoming events for Student Government and the Campus Activities Board.

## **President's Report**

**European Excursion Club Presentation.** Dr. Dupee introduced Dr. Ron Palmer, professor of history, and three students, Gretta Maitag, Annabelle Atnip and Malena Stevenson, who gave a presentation on a recent overseas trip taken by the European Excursion Club.

Dr. Palmer provided a brief history and overview of the European Excursion Club – it first formed in 1991 and countries experienced thus far include: Ireland, England, Belgium, The Netherlands, Luxembourg, France, Germany and Switzerland. Next year, the club has selected Greece as its destination. Some students have been able to earn credit through HIS 261 and the travel opportunity has expanded to include EDGE students. Recently, Dr. Palmer has worked with SUNY Global on establishing forms, processes, and emergency plans for international travel.

Key benefits for students include personal growth, and gaining a global perspective, along with practical and employable skills and confidence. The April trip included 28 students and four chaperones. Each student talked about what they learned or experienced which included seeing firsthand the key historic locations they learned about in class (i.e. Dachau concentration camp, Anne Frank's house), and learning how to navigate transportation in a foreign country which gave one student the confidence to travel more. One student had never flown before. Another student was so

impressed by the trip (taken as a high school EDGE senior), he decided to attend Jefferson instead of a four-year college as originally planned.

Questions and discussion pertained to cost (students paid \$3700 out of pocket; Foundation assists with some costs), who leads the tours, and how Dr. Palmer markets this travel opportunity.

Trustees gave kudos to Dr. Palmer for spearheading this tremendous opportunity for students each year.

**President's Report**. In his report, Dr. Dupee updated Trustees on enrollment, campus initiatives, events and recent activities. Notables include:

- Summer enrollment is down 8% (73 credits) from last year; fall is currently down 1% as compared to last year.
- The NYS Budget was passed with 100% floor funding for community colleges, but only \$8M additional funding to be split among 30 institutions. It is classified as state operating aid, but it is unclear how the Chancellor will administer the funds.
- NYCCAP and NYCCT are meeting tomorrow on next budget advocacy steps. Although the FY25 State budget is set, the work is just beginning for the next budget cycle.
- The NextMove NY application is due Friday. Megan Stadler is drafting the application with two areas of focus: renovations to building 3 and implementation of predetermined PLA for transitioning Soldiers.
- The Middle States visit was extremely positive. The College received zero requirements for correction, nineteen instances of "collegial advice" and only four recommendations. Additionally, the College received twelve commendations. President Dupee reviewed each of the commendations. Next steps the Visiting Team report will be uploaded to Middle States on May 6, Jefferson's Institutional Response is due by May 13, and the Team Chair will brief Middle States on May 18. The Middle States Commission on Higher Education will take action on the College's accreditation in late June/early July.
- Recent events include the Phi Theta Kappa Awards Ceremony and SUNY Chancellor's Awards for Student Excellence Ceremony both in Albany, a presentation to the Faculty Council of Community Colleges, Cannoneers Softball Cookout, DEISJ Campus Committee meeting and SUNY 2030 Workforce meeting. Additionally, Springfest was held earlier today – President Dupee and VP Pond were among those taking part in the dunk tank benefit. Over \$1000 was raised for the College's food pantry.

# Finance and Audit Committee - Committee Chair Damon Draught

Trustee Draught noted the Finance and Audit Committee has six 2023-2024 budget amendments for Board action. Each resolution acknowledges new funding including for two Center for Community Studies projects in resolutions 128-24 and 129-24, support services funding for students with disabilities in Resolution 130-24, and workforce training funding from SUNY in Resolution 133-24. Resolutions 131-24 and 132-24 acknowledge SUNY 2020 funding of which the College has received a little more than \$3.9 million total. Resolution 131-24 allocates \$1.35 million for renovations to Building 3 on campus, and Resolution 132-24 designates \$700,000 to equip the Lewis County Ed Center with welding stations.

Upon presentation and motion by Damon Draught, seconded by Judy Gentner, Resolutions 128-24, 129-24, 130-24, 131-24, 132-24 and 133-24 were approved unanimously as follows:

## Financial Statements: March 2024

Vice President Sid Pond provided a brief overview of unaudited March 2024 financial reports, noting that 7 months into the fiscal year, overall total revenue is just shy of \$23,159,000, and is 90% of total budgeted revenues through March. Fall, Winter, and Spring tuition revenue are all coming in lower than budget since actual enrollment has been lower than anticipated. Overall expenditures are about 5% less than budgeted expenditures at this point in time. The College continues to offset the reduction in tuition revenue by managing spending. The balance sheet is in good financial position, and the College continues to invest the cash on hand to maximize return.
